### Masters of Divinity Financial Affidavit

Documentation of financial resources (within 6 months) is one of the requirements of the USCIS (United States Citizenship and Immigration Services) for each applicant who is not a United States citizen or a Permanent Resident **before** the Global Engagement Office can issue a Certificate of Eligibility (I-20 or DS-2019). All three parts must be completed. Additional or alternate documentation for Part III from banks, other financial institutions or governmental agencies must be submitted on official letterhead paper and include the original signature of an official representative, with the amount of money translated into U.S. dollars. If you will receive a scholarship, include a copy of the official award letter.
